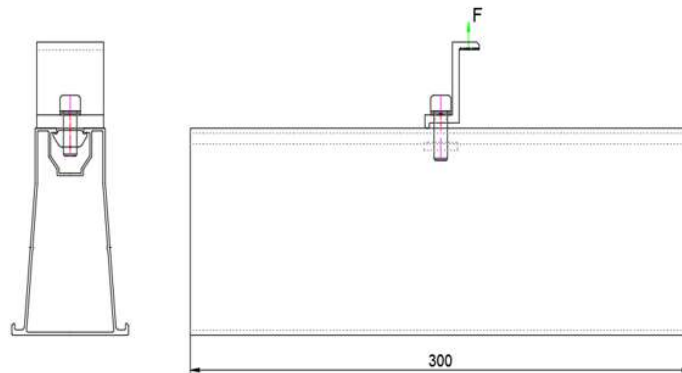

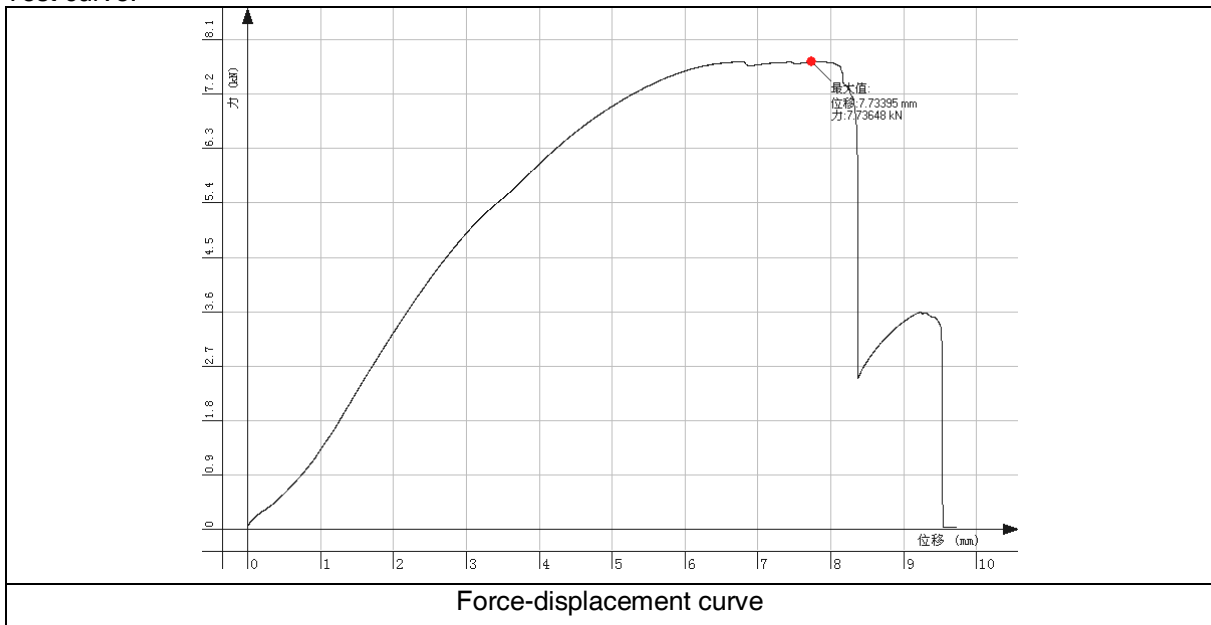

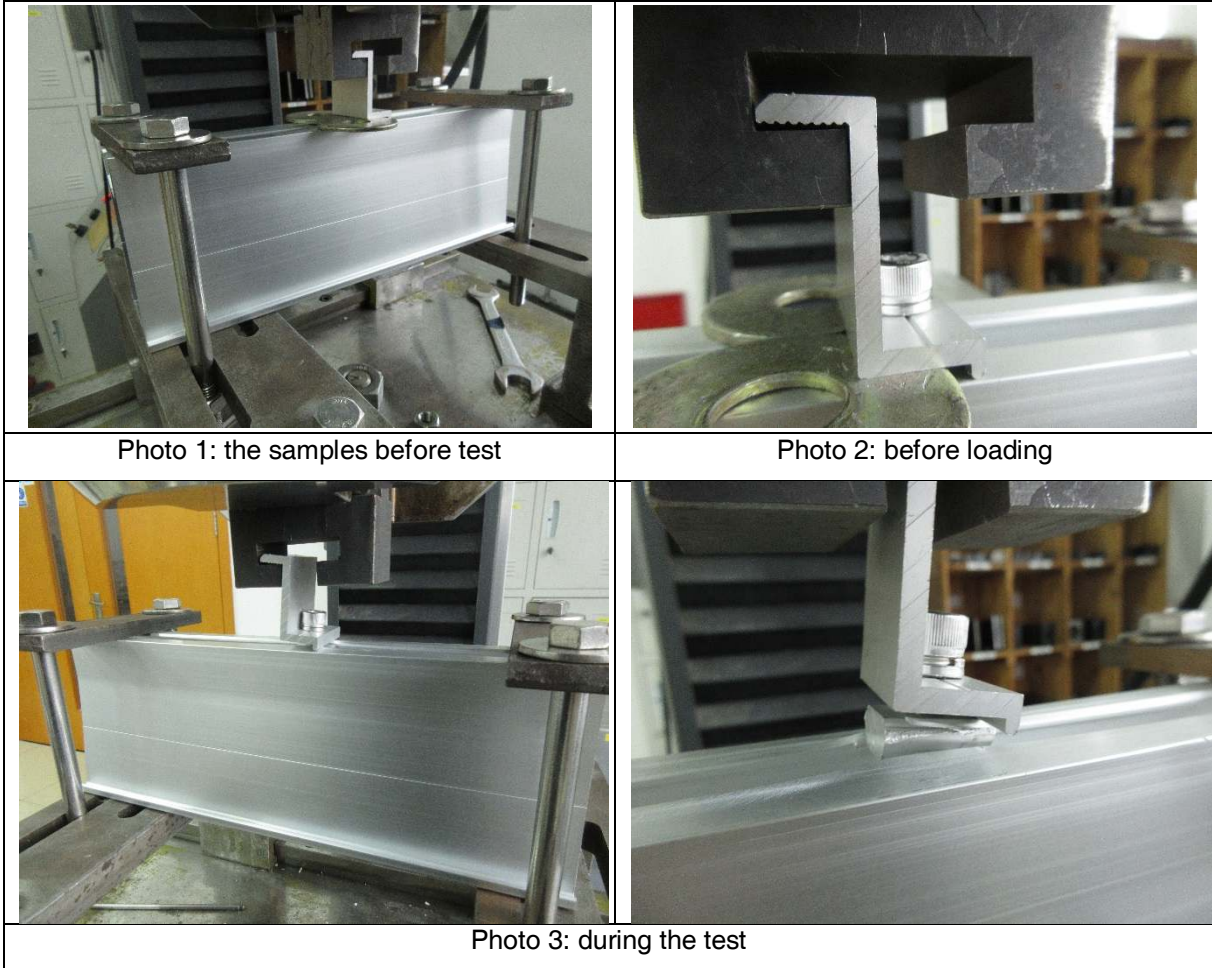


Photo 1: the samples before test
